The conditions of a postbaccalaureate admission are the same as for nondegree graduate status: a) admission status terminates after completion of 18 graduate hours, b) admission to nondegree status does not constitute admission to the graduate degree program, c) credit earned cannot normally be applied toward a graduate degree at Ohio University. Some graduate courses, such as those in the M.B.A. program, are not open to students admitted to postbaccalaureate status. If in doubt about the acceptability of postbaccalaureate status for a specific course, check with the department offering the course.
